4. Dixie Fire Canopy Project – Funding Request
  - o Received grant – giveaway/planting to beautify the main byways of the Greenville area (just Main Street) – total grant \$5,000 – they pay 50% upfront – the second 50% after the event. To complete the event they need the entire \$5,000. They are looking for a loan to complete the event – they will reimburse the loan once the grant is received.
    - If they are unable to complete the event – the money comes back immediately and is reimbursed once the reporting is completed for the grant.
